## **General Comments**

## Telephone Monitoring Inspection

Operator confirmed that she has introduced a pet into the ELC Facility, that the dog has access to the children and is free to roam in the facility. She confirmed that parental/guardian written consent was not obtained and that she had not reviewed the Health Standards under the Public Health Act nor the Operator Manual prior to introducing the pet into the ELC Facility.

Parents must be consulted and provide written consent prior to introducing any animals into the facility. Parents are informed of the benefits of engaging and interacting with animals, as well as the risks (for example, allergies, infectious disease transmission and injury) and how the facility plans to lessen those risks. The Parent Handbook must be updated with this information. Parental consents must be obtained by August 5, 2021 and maintained in each child's file.

The Operator must advise the Quality Assurance Monitor in writing, by August 05, 2021 that these Parental consents have been received and placed in the children's files.

The Operator must be informed and follow Public Health Inspection Standards, Guidelines for the Prevention and Control of Communicable Diseases in Early Learning and Childcare ELC Facility and the Early Childhood Services Act and Regulations (Operator Manual).
