Strategies were discussed on how to apply each item within their group. Observation and reflection were done to evaluate with staff if all the items of the regulation are being applied into their classroom.</li> <li>-Daily routine into the center includes; Outdoor play time at least once every 4 hour blocks time when the weather is permitting. Meal and snacks are served at the recognized hours and a daily rest period that meets the children's needs</li> <li>-Daily incident log is maintained; parent is informed of reportable incidents as soon as possible and signs the report which is kept in the children's file.</li> <li>-Operator advises the Department within 24 hours of reportable incidents</li> <li>-Allergy information on any child is posted in the food preparation area</li> <li>-Drinking water is provided throughout the day</li> <li>-Food brought from home is labeled with the child's name has an ice pack in the lunch box</li> <li>-A new structure was added in the playground, operator has checked the CSA standards and has people coming in to have the play structure up to code.
