The children cannot social distance (6 feet/2meters) on the bus so face masks must be worn when travelling from the school to the school-age program. Discussed with educators and administrator.

(Remove all wheels or replace wheel).</p>

<p>A renewal inspection was conducted today.</p> <p>The school-age room has been divided to support the COVID-19 Recovery Phase of "Bubble Groupings". The floor has a perimeter around it so the children in the "Red Group" can safely access their part of the room without crossing into the "Green Group's" space. Parents enter the building and ring a bell to let the educators know they have arrived to pick up their children. The educators will then bring the child out to meet their parent/guardian.</p> <p>There is an abundance of materials on both sides for the children to interact and engage with. Children in both groups participated in outside and inside play. Lots of laughter was heard during inspection and they children appeared happy and content in their environments and with the school-age educators.</p> <p>Educators were observed redirecting behaviours appropriately and speaking kindly to the children.</p>
