Tables were set up with invitations - Arts and Crafts, Board Games, Building / Lego. Children were observed eating their snacks, drawing, playing Chutes and Ladders, and reading.

Educators were engaged - sitting with the children and taking part in activities.

A conversation was had regarding the side rooms. These rooms are currently being used as storage. The large room is measured for 30 school aged children (maximum group size). The room closest to the window measures for 4 spaces, the middle room measures for 6 spaces, and the room closest to the entry / exit door, measures for 4 spaces. It is recommended that these side rooms be utilized.

A conversation was had regarding centers, and how to make them more defined and exciting for the children. It is recommended that Administrator and Educators review Appendix 24 - Equipment and Materials for Schoolage Children. This section can be found on pages 157 - 173 of the Operator Manual.

Parent Board - The Parent Bulletin Board had fallen down today. Educator stated that they were having issues with this board. If issues continue, a new parent bulletin board will need to be purchased.
