General Comments								
Monitoring visit performed. Licensing staff arrived at the same time the centre bus arrived. All children are familiar with the routine and they removed outer gear and directly washed hands. The Administrator asked the children what is it you do every time you enter the centre. They answered, "wash our hands".  Licensing staff observed lots of activities set up for children to choose. One group is learning to play battleship. The Educator was very patient and provided instructions using language that was easily understood by the children. She provided lots of guidance. Other children split up and either paired up or play with other games and activities. The Administrator brought out a box and asked who might be interested in painting it for another activity. A couple of children volunteered. All children observed playing cooperatively. As indicated above lots of choices were made available. Children will play here and once the older group arrives, they will get ready and head out to Williams Street Park. Children always get lots of opportunities for outdoor play experiences. Administrative records were reviewed, and attendance is tracked, cleaning checklists completed daily, and fire drills are practiced monthly. A notice of illness was posted so staff are advising parents so they are aware of illnesses.  Positive child guidance observed. Educators show patience when explaining rules to games, and educators give children choice of activities. Both educators have a lovely rapport and pleasant demeanor with the children, and they easily address any behavior concerns with ease.
