<p>General Comments</p> <p>Licensing Staff arrived at the facility to conduct a Monitoring Inspection. Upon arrival, one group of children had just arrived and were in the process of putting away personal belongings before washing their hands for afternoon snack. Shortly after, the second and final bus of children arrived. As they entered the facility, hands were washed and the second group had an opportunity to eat afternoon snack. One Educator told the class that they would be taking their group to the park nearby once snack time was over. Children in this group were observed using the washroom and packing up their bookbags before getting ready to go outside. A headcount and rollcall were performed before the group left the facility.</p> <p>The other Educator gathered and sat with their group to go over the plan for the afternoon. The group did a quick game to talk about different seasons and their favorite activities. Shortly after, the Educator explained the craft they would be doing. Some children chose to play soccer at the back of the classroom while the others gathered at a table to do the craft. Today's craft was a mini basketball net made with a plate and cup. The children had a variety of materials to use to decorate their craft such as markers, tape, string, ribbons and pencils. When it was time to clean up, the Educator was heard saying "Orange Pop" to gain the attention of the class. The children would then say, "Everybody stop". The class worked well together to tidy up. Throughout the afternoon the children freely explored different activities such as dress up, reading, coloring and active games. Families were greeted as children got picked up at the end of the day and attendance records were updated.</p> <p>The facility was bright and welcoming upon arrival. The walls have been painted since the last Monitoring Inspection. The children appeared familiar with the daily routine and comfortable with the Educators. Only positive child guidance was observed today. The Educators were attentive to the needs of the children and were often seen walking around the classroom checking in with each group of children. A new staff member was on site today. The staff file was easily located, organized and contained all required documents.</p>
