Tuesday is library day so children walked to the library and sat at the table as the educator passed out a book to each child. More books were placed in middle of table once children were done with their book. A reminder of the transition to a read aloud was given several minutes before to prepare children. A read aloud occurred in the story corner where soft child seats and a large rug were available for children to sit on. Today's book was Millie's Marvelous Hats. The educator held the book up for everyone to see.

After the read aloud, the group returned to their classroom, first stopping to wash hands for snack. Children were aware of the daily routine. One educator sat and ate snack with children while the other prepared a letter activity. Once snack was finished and children cleaned their area, they sat down at a table with a sheet, letters and a marker. Each child was to match their letters to the letters in their name printed on the sheet and then practice printing their name. After completing their name, the children cut out pictures in magazines to match letters in the alphabet.

Documentation was evident throughout the room. Children's photographs were posted throughout the classroom and many different art activities. Children's names were placed on the wall with the number of letters in their name and a child's quote posted beside. Children's names and letters are highlighted throughout this room. The question of the day from yesterday was posted, "Whose side do you believe?" An educator had read the true story of the big bad wolf but discussed 3 little pigs first. After the story, children were asked the
