Comments: A staff member does not have a valid first aid certificate and a valid CPR certificate. The staff is currently registered for the course and is not left alone with children until the course is completed.

Comments: A staff member did not obtain a vulnerable sector check prior to employment. The staff member had to leave the facility and will be able to return once a vulnerable sector check is completed.
