General Comments

Monitoring visit performed.

Upon arrival this AM there were 2 classes of preschoolers, 1 class of 2/3 split, and the babies in another room. This is also a half day for school age children.

In the AM, licensing staff observed educators reading stories to their groups and then they carried on with nice transitions - simon says or freeze dance. Children were observed having fun as they laughed and giggled playing the games with their friends. Outdoor play was not observed today - pouring rain so everyone stayed inside this AM and in the PM.

All children were observed washing hands and eating lunch.

School age children are greeted by 2 staff when they are dropped off by the school bus. This is a 1/2 day. All children are familiar with the routine, and they are given gentle reminders to wash hands when they arrive, collect their lunch boxes and find a chair to sit and eat lunch with their friends. Children are supervised and given lots of time to mingle, clean up, and wash hands before moving onto afternoon activities. School age group had lots of choices for activities - some were coloring, creating with play doh, working on puzzles, building with lego. building with blocks, playing house etc. All children were observed playing cooperatively and educators could easily redirect if needed. All children were treated with respect and kindness and assisted children when necessary.

Babies and 2/3 year olds were observed going down for nap. After eating, the babies relax and look at books before napping and the same happens with the 2/3 year olds. A few children in this group are provided a mat, however they have the option of laying down or playing quietly. Lots of quiet activities are provided to children who wake early from nap.

One observation- please ask educators to cover the bins outside to keep toys and equipment dry.

Programming posted is current in all the rooms. I observed learning stories and one class had a science experiment posted on sinking and floating. Lots of learning opportunities observed that are fun and developmentally appropriated for the children in attendance today.
