## **General Comments**

Upon Licensing Staff's arrival, all children other than the infants, were observed playing outdoors. In the indoor infant space, Educators were making a craft with sparkles and were observed sitting with the children and singing songs. The space was welcoming with nature crafts hanging from the ceiling, a wooden playhouse, books, balls, toys and a soft climbing mat.

Outdoors, in the 2-year-old play area, there was music playing and the children were busy climbing in or on a wooden climbing structure, a wooden boat and wooden train. There was a mud kitchen with kitchen utensils, tricycles, trucks, cars and a flower garden. In the 3–4-year-old space, children were having fun playing on wooden seesaw, a play climber, a large stationary play structure, trucks and cars. In both spaces, Educators were observed offering words of encouragement and praise. There are large shade sails and water bottles were brought outdoors. Educators were engaged and helped the children during the clean-up transition before coming indoors for lunch.

Before eating lunch, the children were observed washing their hands and an Educator sang the ABC song as a fun hand washing timer. Educators in each space sat with the children while they ate their lunch and offered assistance and used gentle words as reminders to eat their lunch. After eating lunch, the infants and the 2-year-old room washed their hands and began quiet time for their naps.

The indoor play spaces in each room were organized, tidy and inviting with wall displays, children's paintings, crafts, and family photos. The children's belongings were organized in cubbies or with hooks and entry ways were clear of clutter. In the Preschool age space, children were observed playing with wooden blocks, costumes, a kitchen, books, magnet tiles, cozy corners and shopping carts with groceries. The 2-year-old space had sensory bins with pinecones and loose pieces for play as well as books, a doll house, cars, trucks and a
