General Comments

Licensing Staff arrived at the facility to perform a Monitoring Inspection. Upon arrival, the children were engaged in a variety of activities. The classrooms are bright and welcoming. Natural light, lamps, plants and wooden materials were observed in each room. Today was a snow day, so numbers were low and school age children were in attendance.

In the preschool classroom, one table was set up with crafting materials such as paper, glue, paint brushes and small pieces of colored paper towel. Other children were observed reading books, doing floor puzzles together and playing in the play kitchen area. A group of children were seen laughing and smiling as they transformed the play kitchen area into a restaurant. The children were seen making pancakes, flipping them to make sure both sides were cooked.

In the infant's room, a colorful light and music was on as the infants had a dance party with their Educator. After the dance party, the infants sat with the Educator to sing some of their favorite songs together. Proper diaper changing procedures were observed and hands were washed before the infants sat for lunch. The Educator was very attentive to their needs and encouraging language.

The school age children engaged in a variety of activities throughout the morning. A group of children worked together to build a large wooden pathway. In another section of the classroom, the children had min sticks and were observed playing a game of hockey. Others were seen reading, drawing and playing with LOL dolls.

Throughout the visit, the Educators were actively engaged with the children, often sitting at a table with them, reading to them and crouching to be at their level when speaking with them. Transition periods were smooth,

the children appeared familiar with the morning routine. Only positive child guidance was observed. Staff files and child profiles were reviewed during today's Monitoring Inspection. Files were easily accessible and contained all required documents.
