<p>General Comments</p> <p>Monitoring Inspection - COVID -19 Recovery Phase:</p> <p>Children engaged in outdoor play this morning.</p> <p>Hand washing routines were observed when the children arrived from outdoor play.</p> <p>All COVID-19 documents are being completed as required and maintained on-site. It is evident staff have been frequently cleaning play areas, high touch areas, washrooms and toys. Toys are being rotated and cleaned twice daily. All toys that are not easily cleaned have been removed from children's play areas. Each after school group has their own labeled washroom and entrance to the cubby room.</p> <p>Documentation is posted throughout the facility highlighting the children's play and learning at this time documentation posted should be in plastic sleeves or laminated so it can be sanitized twice daily with the other</p>
