Comments: Stage carpet unclean. Deep clean of this carpet is needed.			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (b) arranged on low, open shelves and accessible to the children receiving services at the licensed facility,	32(1)(b)	Oct 12, 2020	
Comments: Cupboards with art materials and toys closed and locked. These items were accessible to children however the children did not have access to storage to be able to clean up or choose more materials causing clutter to build up on tables and floor. Open shelving is needed to allow more accessibility to materials and allow children and educators to keep items neat and organized.			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (d) clean and in good repair.	32(1)(d)	Sep 03, 2020	
Comments: Large tables separating the room and train table unclean and cluttered. Tables must be cleaned frequently throughout the day.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Sep 03, 2020	
Comments: Craft Bond (toxic product) on recycling shelf in hallway. Toxic products must be kept locked in all spaces within child care including hallways.			
39(3) Despite paragraph (2)(b), medications administered in cases of anaphylactic shock shall not be stored in a locked space.	39(3)	Sep 02, 2020	
Comments: Epi Pen stored in locked cupboard. Epi Pens must be kept unlocked and stored safely to allow easy access in an emergency. Educator immediately resolved this issue during inspection.			

<p>General Comments</p> <p>Children engaged in a of variety activities this morning. Educators and children observed having meaningful conversations with each other. Photos of the children and open ended art is displayed throughout the learning environment.</p> <p>Documentation of purposefully planned activities must be kept. This could be written in a journal or on a calendar. It is evident that educators have been planning activities however documentation is not being kept.</p>

General Comments

Ensure the date is added to all documentation.

Bookshelves need to be tidied. Books should be displayed in a way that makes reading more inviting to the children. How can this area be improved?

Art areas are cluttered and unorganized. Labeled bins and baskets on open shelving are needed to help the children keep this area tidy. An inviting art area will encourage children to get creative and engage with their peers. How can you make your art area more inviting for the school age children?

Administrator states that they have received a new sun shade to be installed as one of their umbrellas has recently broken in the wind. This will be installed within the next few weeks.

Epi Pen storage - recommend having a labelled bright coloured pencil case or bag to store Epi Pen inside First Aid Kit as educator had difficulty finding it loose in First Aid backpack. A copy of Appendix 4 - Extreme Allergy Management and Emergency Plan must be kept with the Epi Pen and in the child's file.
