| <b>General Comments</b><br><br><p>A Monitoring Inspection was completed this morning. Infant Room – Infants were observed during free play. Educators were observed blowing bubbles and infants were observed smiling, laughing, and reaching for the bubbles. Educators stated that present interests include bubbles, the play kitchen and food, and sensory activities. Diaper changing was observed and diaper changing procedures were followed. A conversation was had with educators and administrator regarding the excessive number of toys / activities in the room. It is recommended that some of these items be stored elsewhere, freeing up some play space.</p> <p>Two/Three Room – Educators were observed setting up the paint table. Children were very excited for painting, and they were observed rushing to the table to find a seat. Children were observed painting pictures. Educators were engaged - talking to the children and asking them about their paintings. A conversation was had with administrator regarding the reading area and ways of making this area cozier for the children. Preschool - Children were arriving from outside at QAM's arrival. Children were observed gathered around a table, playing with a container of snow. QAM overheard the children pondering several questions – "Wonder how long the snow will last", "What would happen if we added paint", "What would happen if we mixed in Cheerios". Educator was engaged, providing appropriate supervision, and taking part in the activity. Several forms of documentation were observed throughout the facility.</p> |
