A Monitoring Inspection was completed this morning.

Infants were observed sitting at their table, mark making. Diaper changing procedures were observed, and educators were also observed putting sunscreen on the children, before their morning walk. Educators stated that the children are presently very interested in their play kitchen, especially with their Velcro food items. The 2/3 group were observed both inside and outside. While inside, children were observed playing with Elsa dolls and blocks. Children were observed washing their hands before snack. While outside, children were observed sliding, playing in the sand box, and playing with dinosaurs. The 4-year-old group, as well as the school aged group, were both on walks during today's inspection. A conversation was had with an educator, regarding a

piece of cribbage, by the club house. It's a small piece, but it is starting to rot. This piece of cribbage will need to be replaced in the near future. Quality Assurance Monitor will continue to assess this piece of cribbage. Positive child guidance techniques were observed in both rooms and outside. Educators were observed giving gentle reminders, understanding children's development, preparing children for transitions, using positive language, taking part in play, and being on the children's level.
