Comments: A new staff member did not have a signed Acts and Regulations form in their file prior to employment. Each staff member must read and sign the declaration before their start date. The administrator must ensure that all required documents for a new staff file are complete and placed in the file prior to the staff member's start date. The administrator promptly obtained the staff member's signature and added the form to the file.  Deficiency is now compliant

Comments: The Quality Assurance Monitor observed that in one of the classrooms, only 8 children were signed in, although 9 were in attendance. The educator must ensure that children's daily attendance records are completed promptly and accurately. The educator immediately added the child's name and the arrival time of the child.  Deficiency is now compliant			
30(3) An operator shall maintain the indoor play area of a licensed facility to ensure the safety of the children.	30(3)	Jan 07, 2026	Jan 07, 2026
Comments: During the Monitoring Inspection it was observed that a toy bed was obstructing the classroom gate, preventing it from opening fully. The administrator must ensure that the area remains safe and clear of any obstructions to exits. An educator promptly moved the toy bed away from the door.  Deficiency is now compliant
