### General Comments

Renewal Inspection – October 21 (Morning and Afternoon)  
The child-to-staff ratio is respected in the mixed group (preschool and after-school).  
Upon arrival, the children had just finished their snack and were engaged in free play. A Halloween-themed

coloring activity was observed. Due to rain, the preschool children did not go outside. The preschool group then had lunch, which was provided by their parents. No children were napping during the visit. Although the cots were accessible, they were not in use. School-age children arrive around 3:30 p.m. A snack is served upon their arrival. A review of professional development hours was conducted, but proof of training is missing. The educators and the administrator will need to provide proof of completed training. The administrator's and educators' files are currently in compliance. However, the renewal of the criminal record check and the D.S. check must be completed by December. A reminder is given to submit the renewal application.
