Comments: Most of the science-related materials in the daycare are currently located in the kitchen. Additional materials and loose parts will be added to further support scientific exploration. There will also be opportunities to conduct simple experiments, such as working with plants, using sensory bins, exploring with magnifying glasses and clamps, and engaging in activities involving different textures. A photo of the area or the materials will be sent to me.			

General Comments
During my visit in the morning, the daycare meets the requirements of the Early Childhood Services Act and New Brunswick regulation according to the ratio and the following regulations: No toddlers were present in the daycare during my visit. -Personal belongings are separated and clearly labelled with each child's name. -There is currently no medication in the daycare. If needed, medications are stored in a locked cabinet and kept out of children's reach. No administration was required. -Toxic, chemical, and cleaning products in the daycare are stored in a locked area and kept out of children's reach. -The most recent minor incidents, which occurred in 2023, were documented and signed by the parents. No major incidents were reported. - Daily activities have been reviewed, and planning is done on a monthly basis. To improve documentation, a photo album will be created and made accessible to the children so they can reflect on their learning. Observation of the morning snack for four children, as well as the arrival of three others. Most of the children are not present, they won't be going outside this morning, and the administrator has informed me that some of them don't have clothing suitable for the season.
