The Quality Assurance Monitor asked the staff if they have an administrator on site. The educators confirmed that there are no administrators on site overseeing the day-to-day operations at the location. The Quality Assurance Monitor then had a discussion with the operator regarding the need to have an administrator at this location every day. The Quality Assurance Monitor went over duties and responsibilities of an administrator and their importance in ensuring proper functioning in a facility. The operator has confirmed that they will be appointing someone to complete this role. The Quality Assurance Monitor has reminded the operator that an application for change will need to be sent to the Quality Assurance Monitor once they have determined who will be stepping into this role.
