<p>Comments: Some Covid-19 measure are not being met. Inspector was screened at front door. Inspector had to request to have name recorded on visitor log. Toys are not being cleaned daily. Inspector asked Administrator to create a plan for identifying which toys are being used daily to ensure daily cleaning. Cleaning list must be created and filled in each day. Blankets used to cover sofa for sanitary reasons continue to come off and be used by children. Administrator stated that proper covers were ordered. Children's masks are hung on bulletin board and are not identified by labels, and are touching.</p>
