Comments: Several child files are missing consents for transportation. If children are being transported by vehicle they must have consents.

Comments: Groupings protocols for Covid-19 are not being respected, with groupings being changed daily. Covid-19 groupings may only be changed once per week. Inspector spoke with Educator and Administrator and a plan is to be created to meet these protocols.			
32(1) An operator of a licensed facility shall provide indoor play area materials and equipment that are (b) arranged on low, open shelves and accessible to the children receiving services at the licensed facility,	32(1)(b)	May 13, 2021	May 13, 2021
Comments: Shelving unit for toys were turned towards walls so that toys were inaccessible. Cupboards have toys and art supplies but children must ask for these items. Inspector asked Educator to turn shelves around to provide options to children. Children were playing with art supplies and new building stick items that had been recently purchased at this time. Deficiency is now compliant			

General Comments

Inspector observed educators dealing with difficult behaviors in a positive way.

Inspector asks Administrator to ensure groupings are changed only once per week and that this be recorded on groupings forms.
