The corporation director of the facility did not have a valid criminal record /vulnerable sector check in his file. Administrator on site was able to show QA monitor a picture of a valid check. Administrator will send an email confirmation when the check is inserted in the corporation director's file.							
She verified if all documents needed were posted in a visible and prominent place in the facility. She also verified educators programming books. QA monitor could see purposely planned and documented activities that respond to the capabilities, needs and interests of each child.							
The contact information of the QA monitor was not updated after the changes. QA monitor left her business card for the administrator to post in the facility.							
QA monitor observed children play indoors. Positive interactions between educators and children were observed.
