An educator's staff file was not located on the premises. Administrator had a copy delivered from the other location. All required documents & checks were in the file.

Quality Assurance Monitor observed that all classrooms have planning tools and evidence of children's learning on display. Recommend that Administrator provide additional support to infant educators who are new to this age group. QAM will send some resources to the Administrator that they might find helpful in developing a reflective practice. Administrator can also reach out to the Curriculum Support team for additional resources.
