Comments: During the follow-up inspection, the inspector observed that purposely planned activities are missing in 1 of the 2 classrooms. The administrator must ensure that programming is deliberately planned.			
24(1) For the purposes of subsection 20(1) of the Act, the following records and documents shall be maintained on the premises of a licensed facility: (b) child records that include: (ii) the name, address and telephone number of the child's medical practitioner.	24(1)(b)(ii)	Oct 14, 2022	Nov 21, 2022
Comments: During the follow-up inspection, the inspector observed that the name, address and telephone number of the child's medical practitioner was present in the 5 child files verified. Deficiency is now compliant.			
33(2) Stationary equipment in the outdoor play area shall be surrounded by a protective surfacing and installed according to the manufacturer's instructions.	33(2)	Nov 25, 2022	
Comments: During the follow-up inspection, the inspector observed that the protective surfacing around the dome is not sufficient. The administrator must ensure to maintain adequate depth of protective surfacing around the dome as prescribed by the manufacturer's manual. Children are not to play on the dome until the protective surfacing surrounding the dome is at the depth prescribed by the manufacturer's manual.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (a) toxic products, chemical products and cleaning supplies;	39(2)(a)	Nov 21, 2022	Nov 21, 2022
Comments: During the follow-up inspection, the inspector observed a spray bottle filled with a Mr. Clean and water located inside one of the classrooms. Cleaning products should be locked up and inaccessible to children. During the inspection, the educator placed the Mr. Clean solution in a locked cupboard. Deficiency is now compliant.			
39(2) A licensed facility shall have a separate locked storage space that is inaccessible to the children for each of the following: (b) medications.	39(2)(b)	Oct 11, 2022	Nov 21, 2022
Comments: During the follow-up inspection, the inspector observed that medication was locked and inaccessible to children. Deficiency is now compliant.			
45(1) An operator of a licensed facility shall require a parent or guardian of a child receiving services at the licensed facility to (b) indicate whether the absence is due to illness or otherwise.	45(1)(b)	Oct 12, 2022	Nov 21, 2022

Comments: During the follow-up inspection, the inspector observed that the reason for absences is indicated on the daily attendance sheets. Deficiency is now compliant.			
48(2) An operator of a licensed facility may supply food to a child receiving services at the licensed facility that a parent or guardian of the child brings from the child's home if the food is labelled with the child's name and refrigerated, as required.	48(2)	Nov 23, 2022	
Comments: During the follow-up inspection, the inspector observed that 3 out of 6 lunchboxes were not labelled with the child's name. All food brought from home must be labeled with the child's name.
