<p>General Comments</p> <p>Monitoring inspection performed. A couple of compliances to address. Covid guidelines are followed and licensing staff was screened prior to entry and was signed in on the log sheet Administrative records were reviewed - fire drills are being performed monthly. Staff records were reviewed. Educators were observed engaged and participating in children's play. They seemed very warm and speaking kindly to the children. Lots of positive interaction observed. The 2's were involved in a variety of activities - mark making, block play, listening to a story before lunch. I observed babies eating their lunch and getting ready for nap. Preschool age children were observed coming in from outdoors and eating their lunch before having a quiet time on mats. Lovely programming posted - be sure to date learning stories. All children had an opportunity to go outside this AM. Children will be making snow doh this afternoon and celebrating a Birthday in the preschool room. Lunch today - fish sticks, hashbrowns, corn and milk. Children bring snacks from home. The building is lovely and cool indoors. Staff made a point of turning down blinds and closing drapes when they arrived at work this morning. Humidex forecast is 40oC so children will remain indoors for the remainder of the day. Outdoor play space provides lots of natural shade, and wooded areas keep the playground cool in the hot weather too!</p>
