Children were observed at play in the outdoor play area during my visit. They were seen playing in the sandbox, playing in the mud kitchen, listening to an educator read a story, running about and testing their balancing and jumping skills on tires. They have a new tunnel culvert and children were playing inside and around it. I would recommend protective surfacing be added around the climbing posts. One child was observed losing their balance and falling off and another child practicing their balancing skills also fell. For these reasons I suggest mulch or other protective surface that will protect children from injury. Licensing staff also noticed a few of the posts are starting to loosen making them unsturdy for children to play on.

A couple of walkway boards need replaced as little feet could easily turn their ankle if they stepped onto the broken board. An educator was observed comforting a child that had slipped and fallen in the yard. they just needed a hug which the educator was happy to give.

All children were observed eating lunch and going down for nap or quiet time. Educator provide lots of transition tie between activities and were overheard saying "10 minutes more" before we clean up and get ready for quiet time.

This facility provides a monthly newsletter to parents reminding them of special dates and other activities. Appropriate quiet music played while children moved into naptime.

Administrative records were reviewed and attendance, infant toddler records, fire drills, outdoor checklist and incident reports are being tracked. All in order and kept stored neatly in a storage box.. Attendance tracked in binders.

Documentation of children's learning stories were current and posted throughout the centre. Lots of wonderful learning activities observed.
