<p><b>General Comments</b></p> <p>Licensing Staff arrived at the facility to conduct a Monitoring Inspection. Upon arrival, the children were in the process of waking up from nap time. In the 2-year-old classroom, one Educator was observed changing diapers and washing hands. The Educator sang songs with the children as they waited their turn. In the classroom, the other Educator put away napping materials and set up the tables for afternoon snack. In the 3- and 4-year-old classroom the children were sitting at the table eating afternoon snack. As they finished, bookbags were packed for end of day and they were observed having free play. A small group of children put silk scarves on, pretending they were ghosts while others played with magnetic tiles.</p> <p>Later in the afternoon the classes prepared to go outside. All Educators were observed sitting with the children as they put on snowpants, hats and mittens. The Educators were heard using encouraging words and cheering them on as they got ready. Once half of the class was ready, an Educator took them outside while the other Educator got the rest of the group ready. The transition from inside to the outdoor play area was smooth. Outside the children were eager to slide down a small icy hill. One Educator sat at the top while another Educator stayed at the bottom. The children were heard laughing as they slid down the hill.</p> <p>The indoor environment was bright, organized and welcoming. Family pictures, artwork and daily schedules were observed in each classroom. Current learning stories with ties to the curriculum were posted throughout the facility. Only positive child guidance was observed during today's Monitoring Inspection. The Educators spoke in a respectful and kind tone when interacting with the children. Educators were observed offering praise "Great job, you did it by yourself!" and celebrating the children's achievements.</p>
