General Comments

When I arrived, the two groups were combined in one room and then separated into each their rooms. There was a total of 17 children in the room and the room only measures for 15 children. Therefore, the group was over the number of children allowed in that room.

In the morning, I observed the children playing with different activities. Some did arts and crafts, others played with the safari animal figurines and some played with wooden blocks. Around 9:30, the children had snack. Following snack everyone got ready to go outside, the children played outside until lunch time. In the afternoon, the children played inside and then they went outside for a presentation about butterflies from NB Nature. This was a very interesting activity and the children really enjoyed it. Great idea!

I see that cameras have been installed in the facility; this must be included in the parent handbook. Please make note of the Appendix 27 of the Operator Manual that stats:

• Operators are to include a statement in their parent handbook stating that they use audio/video recording.

The outdoor play space has a nice natural feel to it and most play items are made from wood. The children seem to really enjoy the natural aspect of their outdoor play space.

The outdoor play space must be cleaned up and re-organized. There is allot of garbage such has plastic bags and chip bags and many toys/equipment that are broken. In the mud kitchen area, there are many pieces of wood that are damaged, nails sticking out and don't seem to have a purpose, some metal pans are broken, rusted and/or have sharp edges and the sink is also rusted and has exposed sharp edges. In the sandbox area there are many pieces of wood that also have metal parts sticking out of them and some wood pieces seem to be overused and don't seem to have a purpose. There is also lots of abandoned toys all around the wooded area that should be brought into the play area so the children can have access to them. The storage bins also have broken toys and items in them like cans and other debris. All toys and equipment that is broken, overused or poses a safety risk to the children should be removed and replaced with new ones.

Please ensure that all manufactures instructions for the zipline are followed. If it requires protective surfacing, then this should be added. The large wood structure is considered stationary equipment and must have 30 cm's of protective surfacing all around it, including around the swing area.

There is also pooling water that should be filled in with dirt or sand.

I found multiple children files missing consent forms and many have outdated consent forms. All children files must have consent forms. Please ensure all files are verified and updated with missing information.

A reminder that cell phone use should be limited to business only to contact parents during urgent matters. I recommend that a cell policy is implemented and reviewed with the staff.
