above). One staff record was not on site, but this was corrected during my visit. It was also observed that parents are advising the centre when children are going to be absent and the reason for absence. This was documented on the attendance record.

Children were observed in outdoor play, enjoying sliding. Educators were assisting and participating in children's play. They were also observed helping children with putting on mittens when they fell off or to remove snow from their boots. Children were having a lot of fun playing in the snow.
