<b>General Comments</b>
<p>Licensing Staff arrived at the facility to perform a Monitoring Inspection. Upon arrival, the children were having free play. Some of the infants were stacking wooden blocks while others played in the play kitchen area. The Educators were seen clapping and cheering with the infants, "Great job! Look what you did! Let's clap our hands!". Shortly after my arrival one Educator took a group of infants to do some painting while the other Educator sat and played with the others. All infants had a turn painting.</p> <p>An Educator sat with the class, singing songs before cleaning up and preparing for lunch. The transition was smooth. Christmas music was put on and they had the opportunity to dance while waiting to wash their hands for lunch. Proper diaper changing procedures and hand washing was observed before eating. The Educators were respectful, patient and have a calm demeanor when interacting with the infants.</p> <p>The indoor environment is organized, clean and inviting. There's a variety of current learning stories, class artwork and pictures throughout the facility. The Educators were observed re-directing the infants when needed and were attentive to their needs, offering hugs and kind words of encouragement. Only positive child guidance was observed during today's visit. Daily information sheets and attendance records were up to date.</p>
