General Comments

Today was my first visit to Bluebell Montessori. I was welcomed by the Operator and educators and given a tour and introduced to the children.

Children were engaged in their "work cycle" and I observed children using a variety of Montessori materials. Halloween elements were added to some learning invitations such as Halloween ribbon, pumpkin and scarecrow pictures to paint, google eyes with black construction paper and chalk. Educators have excellent child guidance techniques and all children are spoken to with such kindness and respect.

Child files were verified and all is in order.

While educators worked hard to ensure that all areas of the open concept layout of the space were supervised most of the time, I did observe one educator over ratio with all twenty children during circle time, While the educator and operator were doing other tasks such as cleaning up, wiping tables, filling up soap for the bathrooms and ensuring that the centre stays clean and surfaces sanitized, it is imperative that ratios are maintained at all times.

While reviewing staff files, it was noted that a new employee only had a confirmation that she had requested a Criminal Record/Vulnerable Sector Check. Because the check had not been yet completed/returned this staff was sent home. She was able to go to the Police Station and get the check that afternoon. Please ensure that staff files are complete with all required paperwork prior to their first day,
