Comments:	Although all items that must be posted are posted on a bulletin board, the bulletin board is located in the kitchen which is not a prominent place were parents or anyone entering the building would have access to it. The intent of this regulation is for parents, staff members and anyone entering the facility are aware of the licence status and important information about the facility. Therefore, the information board must be moved near the entrance where parents pick up the children.

When I arrived one group was eating snack and the other was doing some art. The theme of the camp this week is Art. Around 11:15 the children came together as one group for circle time and then went outside until lunch.

The centre is clean and organized. Different types of Montessori materials are available to the children such has materials for literacy, science and arts.

The atmosphere is quiet and calm, the children move freely and calmly from one activity to another.

Positive child guidance was observed such has gentle reminders, encouragements, and positive reinforcement. Staff were observed speaking to children at their level with a clam tone.

The staff promote an environment that encourages positive behavior by allowing the children enough time for activities, by preparing the children for transition, involving them by given them responsibilities that are age appropriate and allowing them to help, use positive language when interacting with them and by respecting children's feelings.

Fire drills and first aid kit inspections must be done monthly. Today is the last day of July, please ensure those are completed today.
