Children were engaged in a number of various activities during the morning. Children in the back room were decorating paper snowflakes, completing a penguin puzzle and there were other resources to learn about arctic animals.

This was noted on the annual inspection report and remains in non-compliance.

In the front room, some children were having snack while others used practical life materials. Some children were using cloths and dusters while others had aprons on and were able to spray the windows with small bits of water and practice using a squeegee.

I observed the educator's using patience and compassion when children were putting on their outdoor winter clothing. They promoted independence and offered assistance when needed. Educators were also seen on many different occasions getting down to the children's level and using a calm, low voice.

Ratios were maintained and maximum room sizes were followed.

All required postings are on a bulletin board by the entrance.

Children went outdoors before lunch and this transition was smooth. Educators confirmed their group attendance and did head counts while leaving the building to go to the yard.

The gate to the fenced play area is in good working order and opened with ease and latched properly. There were spaces for climbing and sitting, blocks, shovels, wheelbarrow and tires. Children also enjoyed playing with the dinosaur figurines.
