<p>A Monitoring Inspection was completed this morning. Children were observed finishing lunch at QAM's arrival. Children were observed during quiet time activities. Several tables were set up with quiet time activities, and children were observed moving around to the activities that they were interested in. Activities included: Geo Boards, Building Blocks, and Arts & Crafts. Eight children were present today, and all eight children were observed on the preschool side of the room. Educators stated that the children are presently interested in Arts & Crafts, Paw Patrol, Trucks, Play Doh, and building forts. A new wooden house was observed on the preschool side of the room. Children were observed playing inside this house. The house was decorated for Halloween. Several well-defined centers were observed on the two's side, the preschool side, and the school aged classroom. Several forms of documentation were observed in all areas - photos, children's artwork, webs, etc. Each child also had their very own binder, showcasing their artwork and activities. The parent board was observed. The menu, the most recent monitoring and renewal inspections, a list of the Board of Directors, and contact information for both the Quality Assurance Monitor and Inspector were observed. The daily schedule and a list of allergies were also observed. Fire evacuation records were observed for the 2's, preschool, and school aged areas. All fire evacuation records were up to date. Attendance records were observed and accurate. Two staff files were observed.</p>
