<p>A follow up inspection occurred today.</p> <p>All orders for compliance are completed and the facility is recommended for license renewal.</p> <p>The preschool room now has 2-year-olds as well as 3- and 4-year-olds. A diaper changing station has been added to help support diaper changing with this younger age group.</p> <p>Two educators still have 2.5 hours of Professional Hours to complete prior to the license expiration. The Quality Assurance Monitor will follow up on this on a monitoring inspection. The Administrators indicated they have plan to complete Inclusion Training to complete their PL.</p>
