General Comments

A monitoring inspection occurred on May 8, 2025.

Children in the two-year-old room were observed climbing the play structure in classroom upon arrival. Educator indicated the children's current interests are cars, trucks, building and planting.

Preschool children were observed engaged in a variety of activities such as a flower sensory bin, reading and open-ended art. Educators indicated the children's current interests are reading, games, plants, flowers and art Educators have a variety of plants in the room and flower sensory bins to expand on the children's interests. Educators stated children help to water the plants in the classroom.

Children were observed eating lunch. Proper handwashing procedures were followed before mealtime. Educators were observed sitting at the table engaging in conversation with the children at lunch time.

Various documentation such as learning stories, pictures, individual portfolios and classroom portfolios were observed in both rooms. In addition, documentation was observed in the hallways leading into the classrooms. Opportunities for individual and group learning experiences was observed.

The following documents were reviewed and complete: incident logs, monthly fire drills, and daily attendance records.

A discussion occurred between licensing and Administration for the following.

Standing water in outside play yard. Administrator stated there is plan in place for drainage to be dug to prevent standing water. Educator to ensure children are not permitted to play in water.

Wooden mud kitchen beside barn had broken, decaying wood. Administrator stated work order is in place to have mud kitchen removed; children are not permitted to play with mud kitchen. Will be removed within two weeks.

Light fixture in Two/Three class not working. Administrator stated a work order is in place to have repaired, no date for when it will be repaired was provided.

Licensing recommended outside check list be created to check play yard before outside play. Goose feces was observed outside play yard fence on monitoring.

One wood piece on grey picnic table inside classroom is splintering to be repaired or replaced.

Educators to ensure paint is accessible and out for children all times in the day.
