Recommending the addition of mulch/pea gravel adjacent to the climbing wall and under the airplane.

Discussed with Administrator activities that the children had been participating in during the summer. The children had been on field trips to Roosevelt Cottage, Herring Cove Park and a planned trip to Edith Lank Camp was upcoming soon.

Educators were observed sitting with the children during snack and lunch engaged in conversation with them.
