General Comments

A Monitoring Inspection occurred January 23, 2025.

Children were observed engaging in indoor free play, demonstrating active exploration and creativity. Educators noted that the children are currently interested in several activities, including being active outdoors, checking off items on their Bucket List, exploring creatures of the sea, creating Valentine's art, and investigating the properties of sand in a sensory table. Throughout the observation, educators used positive language and provided gentle reminders to support the children.

The facility maintains a daily incident log and ensures outdoor play occurs for at least one hour within every four-hour block of time when most children are present, weather permitting. Monthly emergency evacuations are conducted, and evacuation procedures are prominently displayed. The license, inspection reports, monitoring reports, and any compliance orders are also posted in a clearly visible location.

Daily routines are posted in each room, providing structure and predictability for children. Ideas from learning stories and resources from the web are thoughtfully integrated into various areas, including the art area, library, kitchen, and dramatic play areas. Sensory play is well-supported with sufficient sand and a variety of accessories, which are rotated regularly to maintain engagement. The facility also features well-defined learning and play areas, with children's artwork displayed throughout. Traffic areas and outdoor walkways are kept clean and free of clutter. The diaper-changing area is situated within one meter of a sink, and procedures are posted and visible to ensure proper hygiene practices.

The curriculum incorporates both individual and group learning experiences. Children's portfolios are being actively developed, and several forms of documentation were observed throughout the facility. Webs created with the children have been expanded upon collaboratively with educators, enhancing the depth and richness of learning experiences.

A discussion with the administrator addressed concerns about the Rink washroom during daycare hours, ensuring compliance with safety protocols and the secure storage of toxic products to safeguard the children's environment.
