General Comments
<p>The compliances that were given at time of annual inspection were not completed upon inspectors arrival to the facility to complete a follow-up to the inspection.</p> <p>The kitchen area was open and unlocked and several of the cupboards contained toxic products including Lysol wipes, Vim, Clorox, and Old Dutch bleach. The educator was asked if they had a key to the office and the reply was yes. Licensing staff asked the educator to move all toxic products into the office and lock the door which they did at the time of visit. Licensing staff advised educator that toxics and medications should be locked in the office until a lock can be obtained for kitchen, or cupboards in the kitchen.</p> <p>Also, The inspector's name was still not evident on the bulletin board. One of the educator's wrote the inspectors name and number on the contact list at time of visit. Please also note that the coordinator position no longer exists. The other position should state Quality Assurance Monitor.</p> <p>Also, noted was that the current renewal inspection and monitoring inspection was not posted. Please ensure that the annual inspection including the follow-up visits are posted for the year and monitoring visits are interchanged as the Quality Assurance Monitor conducts visits at the facility.</p>

General Comments

The non compliances that were evident during the annual inspection were put into compliance at time of follow-up visit and therefore the licensing staff can recommend facility for licensing.
