At the time of visit, it was noted that in the cubbie area was quite dirty and book bags and belongings were all over the floor. There was also a foul order coming from this area. Please ensure that the children are encouraged to put their belongings in their labelled cubbies to keep it seperate from others. This area must be cleaning immediately.

## **General Comments**

There was an empty Tim Hortons coffee cup on the table of the children's play area. There did not appear to be any coffee in it. Just a reminder that educators are never permitted to have coffee or hot drinks with the children present.

Licensing staff did observe good interactions between educators and the children. One of the educators was very involved in the physical play with the children while another colored with some children at the table.
