General Comments

Nancy Glendenning and Jennifer Godin arrived at the facility and saw positive changes immediately. The facility was clean and organized. The Operator had learning centres set up for the children such as building blocks, science, art, reading, and an area for gross motor play. There were enough areas set up for the children on the day of visit, but more centres may have to be created as the child numbers get higher. The room should be set up consistently just like it was on this day of visit.

There was a written program for the children's activities. The written program needs to be consistent weekly and will be verified on a regular basis.

Licensing staff observed a flow of free choice activities and teacher led activities. The children were engaged with the educators both in and outside the facility.

Please ensure that the current Annual renewal inspection report and newest monitoring visit is always posted.

In order to recommend for licensing: The children and staff files need to be completed as outlined in the report. You must also have a full first aid kit at the facility that will accompany you to the park and on other outings.
