The Operator also added beauty salon for the children. The children were very engaged with these materials. As per comments above, please ensure 5 centres are set up prior to the arrival of the children. The Operator had these set up prior to the departure of licensing staff.

As the operator keeps building on new resources for the children, it is recommended that more materials be added to the art centre and more soft materials be added to the reading area.
