General Comments

There have been positive changes made to the environments of the facility's classrooms however the defined interest areas were not easily seen at the time of inspections. To implement, a quality environment, materials must be varied and sufficient in quantity for all children present; easily accessible on low open shelves and arranged to allow opportunities for free choice of activities. The learning environment should include some of the following defined learning centres to enhance learning.

-art materials including loose parts

-blocks and accessories

-dramatic play

-music and movement

-large muscle

-manipulatives and fine motor

-sand and water play

-puzzles and games

-materials that support mathematical learning

-materials that support learning in science and technology

Materials are not to be limited to use in a particular learning centre only, but the centres must be clearly defined. For more information regarding play materials and equipment please consult the Curriculum Framework.

General Comments

Licensing staff will refer facility to curriculum team and quality assurance monitor for support to keep moving forward as having clearly defined centres with a variety materials present is a requirement for both regulation and designation.
