Comments: Deficiency is now compliant While observing the infants playing in the outdoor play environment, licensing staff noted a swing that is not age appropriate for the infants according to the manufacturer's recommendation. Please remove this swing from the infant outdoor play environment to maintain the safety of the children.			

General Comments
<p>Licensing staff arrived at the licensed facility while the children were being dropped off for the day.</p> <p>The children were being dropped off outside today to get in outdoor play time before the pending hot weather.</p> <p>While observing children in the indoor play environment, licensing staff noted an abundance of documentation posted on the walls in the classrooms for the children to revisit their learning experiences. In the three and four year old classroom the educator showed licensing staff a book that the class created as a group. Each child drew a picture of their favourite animal and the educator asked each child to describe their picture and the educator wrote on the page what the child relayed to her. The educator put the drawings and descriptions together as a book and called it "The favourite Animal Book."</p> <p>Licensing staff observed positive child guidance by the educators throughout the inspection.</p> <p>Please ensure all sand pits are covered at night to avoid having wildlife defecating in the sand the children are playing with.</p> <p>Most classrooms had mark making and craft materials accessible to the children. Please ensure all classrooms have mark-making and craft materials accessible to the children at all times.</p>
