General Comments
Licensing staff arrived at center for a monitoring inspection visit.
There seems to be plenty of materials in the classrooms, however the children do not seem interested in the items and many should be updated. Also noticed some broken items in the classrooms and outdoor play space.
We recommend the classrooms have a good cleaning and organized to get rid of the clutter on the shelves and throughout the classroom.
Observed a tripping hazard in the three/four split that needs to be repaired. There are wires by the smart board that need tidied up to prevent a child from possibly pulling them down. There is a light shade hanging in the afterschool class as well.
Stroller was found in the nap area for the infants. This should not be stored in this area.
The floor guard going into the infant section needs to be repaired.

General Comments

Fire drills have been completed for every month except for October. Please remember to complete these.

The educators were engaged with children and at the children's level. The two's room had activities such as finding numbers and matching colors.

The Educator in the 3/4 split room was engaged with the children. He is very patient and calm with the children.
