## **General Comments**

Name of operator

All preschool classrooms were getting ready to go outside when I arrived for today's monitoring follow up inspection. One group of infants were observed getting ready to go for a walk outside, while the second group was on their way to Sobeys to see if they could find any fresh flowers, as that is what they are learning about this week.

While outside, manager went into the baby barn to take out some toys for the children to play with. She was able to take out some plastic horseshoes, large Lego blocks, plastic rackets, rings, and a skip-it. Children were also observed having a dance party while outside.

The outside play space will require additional play material for the children. Please refer to page 169 "Suggested materials and equipment for outdoor play area" from appendix 24 of the Operator Manual, a paper copy of this appendix was also provided to Operator and one for every classroom by facility's Quality Assurance Monitor at time of inspection.

A reminder that the outdoor play area is an extension of the indoor play environment, providing many of the same opportunities, including space for creative, quiet, pretend, and sensory experiences.

While outside, all educators were observed actively supervising children at time of visit. All educators appear to have their own "section" of the outside play space that they are to primarily supervise.

The right-side door of the baby barn in the outside play space appears to have become detached from the top of the frame once door is open. Please ensure to have this fixed for safety reasons.

The play material that is stored in the storage room off of Baby Boulevard is beginning to encroach in the

walkway to the back door, which is used by educators and children to exit the room when they go outside. This door would also be considered a fire escape and must be kept hazard and clutter free.

A reminder that your facility's First Aid kit is to be checked monthly. Records show that facility's First Aid Kit that is by the children's cubbies hasn't been checked since January 2024.

Public Health recommends that cold storage units (refrigerators) storing potentially hazardous foods for children (i.s milk/mixed formula) are monitored and temperatures are recorded. Quality Assurance Monitor will provide Operator with a template for educators to record times and temperatures of fridge in Lullaby Lane nap room where infant bottles are stored.

Quality Assurance Monitor provided Operator and each individual classroom copies of the NB Curriculum Framework, Professional Support Documents, CAT, Link to CAT-RG, Exploring Literacies document, classroom checklists, and additional support reading material.
