Comments: During the follow-up license renewal inspection, licensing staff noted that the infant outdoor play environment does not have any shade for the children to get a reprieve from the sun while playing outside. Please ensure there is sufficient shade for the infants while playing in the outdoor play environment to maintain the infant's safety. The original compliance date to install shade for the infant outdoor play environment was July 11th, 2025.

General Comments
<p>Licensing staff arrived to conduct the follow-up license renewal inspection while children were putting on their outdoor clothing to go outside to play in the outdoor play environment.</p> <p>Licensing staff noted that the books in each classroom are in good repair.</p> <p>Licensing staff also noted that the educator who needed a Criminal Record/Vulnerable Sector Check now has a current Criminal Record/Vulnerable Sector Check.</p> <p>While inspecting the outdoor play environment, licensing staff noted that shade was not installed in the infant outdoor play environment as per recommendation from licensing staff during the License Renewal Inspection that was conducted on July 11th, 2025. In order to maintain the safety of the children while playing outside, there needs to be sufficient shade for the number of infants enrolled at the licensed facility.</p>
