General Comments
<p>Licensing Staff arrived at the facility to conduct a Monitoring Inspection. Upon arrival, the children were engaged in a variety of activities such as building with Lego, using wooden pieces to make a train track and having electronic time. The indoor environment was bright, organized and welcoming. The classroom has been decorated for the upcoming Holiday season. A Christmas tree with colorful lights, beads and ornaments as well as several snowmen crafts were on display throughout the classroom.</p> <p>Shortly after Licensing Staff arrival the children tidied up for morning snack. Today the facility had a special visitor joining for the morning. The children had the option to go see Santa and Mrs.Claus. The children who chose to participate were observed lining up. A headcount was conducted before the children transitioned upstairs to join Santa. While upstairs the children had the opportunity to ask Santa questions, read a story, sing songs and have their photo taken if they wanted. A headcount was observed again before the group transitioned back downstairs to their classroom.</p> <p>Later in the morning the children were seen playing pool at the pool table, making different shapes and patterns with dominos and playing with a large dollhouse with accessories. The children had decorated a door in their classroom to be entered into a contest. The children traced their hands on green construction paper and put them together in the shape of a Christmas tree. This afternoon they get to look at all the decorated doors and chose which one is their favorite. Only positive child guidance was observed during today's Monitoring Inspection. The Educators were observed dancing, laughing and engaged in the activities with the children. Staff and child profiles were reviewed on site today. Files were easily accessed and contained all required documents.</p>
