**General Comments**

Licensing Staff arrived at the facility to conduct a Monitoring Inspection. The children were on site for a full day today since it is a PD day. Upon arrival the children each had their own piece of chart paper and were coloring/drawing. The Educator explained the group is very artist and enjoys coloring. Some children used paint sticks while others used pencils, markers and crayons.

Morning snack was observed. The children sat and ate together at one table. Water bottles were filled and provided to each child. Snack time was earlier than normal; the Educator explained the daily schedule is flexible to meet the needs of the children.

The indoor environment was organized, tidy and bright. The children freely explored different activities throughout the morning. A few children were observed drawing the Canadian Flag on chart paper. The children were curious about the population of the world and different countries. The Educator was observed using "Worldometers" to look up real time statistics with the children. The children had the option to bring their artwork home or hang it up in the classroom. Other children were observed playing on a portable roll up piano and playing a bean bag toss game.

Only positive child guidance was observed today. The Educator follows the interest of the children and expands the learning. The Educator was observed supporting and guiding peers as they worked through a conflict. Attendance records were observed and are being completed properly. All toxic products were stored and locked in a closet and medications are kept in a locked box on top of the fridge.
