Comments: Deficiency is now compliant. The observed interactions between the children and the educators were primarily in English. French was used as a repetition when a child did not appear to understand the initial instruction.			

General Comments
<p>During my unplanned visit in the afternoon, I observed compliance with the ratio for all age groups present. In addition, young children are not mixed with other age groups. The following elements are observed during my visit:</p> <ul style="list-style-type: none"> <li>- The NB curriculum framework used under this licence is English language, and interactions between the children and the educator were conducted in English during my inspection.</li> <li>- Toxic products, chemical products and cleaning supplies are locked and inaccessible to children.</li> <li>- Children's personal belongings are stored separately and clearly labelled with each child's name.</li> <li>- No medication belonging to children is currently on site. When parents bring medication, it is stored in a locked location and kept out of children's reach.</li> <li>- Minor incidents are documented on the centre's designated forms, and none required reporting using the minister's form.</li> </ul> <p>Additional observations include handwashing practices, the snack provided by parents, and the departure of several preschools and school age children. The three-year-old children were outdoors during my visit.</p>
